Foulke, Board Chairman Gary Weyhmuller, The Honorable Thomas Ridge, Former Governor of Pennsylvania and the first United States Secretary of Homeland Security, the Honorable Brian O'Neill, Philadelphia City Councilman, and the Honorable Michael Fitzpatrick, former United States Congressman, were among the community leaders who participated in the building's dedication.

Grady Community Room honors American Heritage's recently-retired Chairperson Cecilia B. Grady, who served on the credit union's Board for more than 30 years.

eNotices and Important Steps

If you are currently enrolled in Online Teller, you will no longer receive paper notifications for items such as overdrafts, returned checks and other account maintenance. In our efforts to reduce paper and improve security, you will now receive a text



message and an email to notify you of an available alert.

You can also easily view an alert at the top of your Mobile Teller app or Online Banking session that will provide you with that notice directly. If you don't already have eStatements, we encourage you to go paperless on your statements as well!

Protecting Yourself - eAlerts & Card Controls

If you have a credit or debit card with American Heritage we offer a valuable privacy benefit in our **Card Controls**. This safety feature allows you to activate a debit card, submit a travel notification, manage overdraft privilege, deactivate a lost or stolen card, change authorization limits and much more.

eAlerts are text or email messages sent to your phone, mobile or desktop device that let you know important information. Messages include direct deposit received, low balance in your account, when checks clear and much more!

During a recent branch visit, you may have been asked to try the PAT® (Personal Automated Teller) machine, a device that resembles an ATM but has a live Teller connected to it. Whether



you decided to try it or not, you may have lingering questions about the machines and wonder why we've added them into our branches.

What is PAT® able to do?

Because a PAT® machine is able to function both as an ATM and as a standard teller, it is capable of performing a variety of tasks. You can use a PAT® machine for cash or check deposits and withdrawals, transfers, loan payments, and account reviews.
