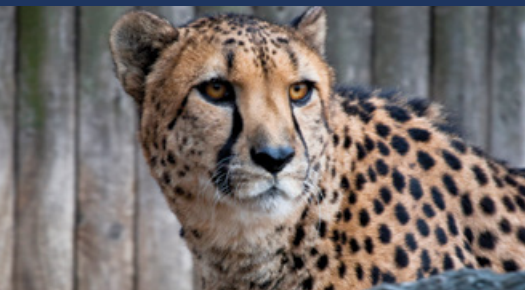

FIGHTING FRAUD

With scam calls on the rise, it is important to educate yourself on common fraud trends and how to avoid becoming a scammer's next victim. A common tactic fraudsters use is posing as a family member in crisis. Take the steps to protect you and your family:

- ★ Come up with a family password to use when an urgent situation is real. Many scam artists will hang up if they're asked "What's the family password?" during the call.
- ★ Ask questions that only a family member in question would know the answer to. Be sure to choose a question where the answer is not easy to find using social media or internet searches.
- ★ Suggest that your loved one hang up and call back using their own contact information like their personal cell phone.
- ★ Stay calm. When panicked, you may miss giveaways like the caller having an unfamiliar voice or accent or calling them "grandma" or "grandpa" instead of their typical "granny" or "poppy."

ADDITIONAL SAFETY TIPS INCLUDE:

- ★ Don't answer calls from unknown numbers. If you answer, hang up immediately.
- ★ If you answer the phone and the caller – or a recording – asks you to hit a button to stop getting the calls, just hang up. Scammers often use this trick to identify potential targets.
- ★ Do not respond to any questions, especially those that can be answered with "Yes" or "No."
- ★ Never give out personal information such as account numbers, Social Security numbers, mother's maiden names, passwords, or other identifying information.
- ★ If you get an inquiry from someone who says they represent a company or a government agency, hang up and call the phone number on your account statement or on the company's or government agency's website to verify the authenticity of the request. You will usually get a written statement in the mail before you get a phone call from a legitimate source, particularly if the caller is asking for a payment.
